What data do we collect?

SECURITUM collects the following data:

- Personal identification information (Name, e-mail address etc.).
- Your network identifiers (IP addresses)

How do we collect your data?

You directly provide SECURITUM with the data we collect. We collect data and process data when you:

- Voluntarily sign-up for a training session;
- Voluntarily complete a newsletter or contact form or respond later via email.
- Use or view our website via your browser's cookies.

How will we use your data?

SECURITUM collects your data so that we can:

- Process the registration for the training.

If you agree, SECURITUM will share your data with our partner companies so that they may offer you their products and services.

- Our datacenter provider who hosts our server (within EU)
- E-mail SMTP internet infrastructure used to send you e-mails: here only Google EU infrastructure is being used

How do we store your data?

SECURITUM securely stores your data at our own headquarters and at our datacenter provider. Our datacenter provider is top 5 European provider of such services. We manage our infrastructure ourselves with securely configured access.

SECURITUM will keep your data until you ask us to be removed/you don't want to receive e-mail notifications from us. Once this time period has expired, we will delete your data within one week.

What are your data protection rights?

SECURITUM would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request SECURITUM for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that SECURITUM correct any information you believe is inaccurate. You also have the right to request SECURITUM to complete the information you believe is incomplete.

The right to erasure – You have the right to request that SECURITUM erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that SECURITUM restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to SECURITUM's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that SECURITUM transfer the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

How do we use cookies?

What types of cookies do we use?

- **Advertising** – SECURITUM uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. SECURITUM sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
